Advocacy

From March 9th to the 20th, the 59th Annual Commission on the Status of Women session was held in New York City. The attendance was the largest ever with over 1100 non-governmental groups taking part. There were over 600 events in various locations. According to UN officials it was 'the largest feminist gathering at the UN'. Attendance was almost double the usual number. It was the anniversary of Beijing + 20.

We had 3 attendees from D4. Lee Fogarty, Advocacy Co-Chair, Doreen Myers, UN Committee and myself. Doreen and I were rookies as we had never attended a CSW before. It was a busy week to say the least. Doreen and I had UN passes so we attended panel discussions and workshops in the UN building. It was a real challenge to pick which events at the UN or off-site that you wanted to attend—there were so many interesting things going on! When you walked into a session you usually had no idea who would be presenting—high ranking government officials or celebrities concerned with women's equality. The UN

Women's slogan is now 50/50 by 2030—the 50/50 referring to gender parity.

For the first time Zonta International was involved with presentations inside the UN building. Our President Maria Jose Landeira Oestergaard handled one and our President-Elect Sonia Honig Schough took part in another. McMaster Golden Z Club

Our Golden Z club partnered with other clubs at McMaster with winter activities. They shared a table with McMaster Muslims for Peace and Justice and raised awareness about cultural appropriation in the form of a "Soul Food Fair", offering henna and nail polish for those who visited the table. They also partnered with the Daughters of Abraham to make sandwiches for the Olive Branch, an outreach ministry for the homeless and poor in downtown Hamilton. In addition, they were involved in the "Bold Run", a fun event that celebrated body diversity and self-acceptance. Proceeds went to Danielle's Place, an eating disorder support and resource centre in Burlington that offers free services to people in the community. In collaboration with McMaster Muslims for Peace and Justice, a women's networking event was held. It celebrated Muslim women leaders who use their professions as a platform for advocacy and activism for the betterment of Muslim and marginalized communities. The purpose of this event was to provide McMaster students

with opportunities to connect and engage with Muslim women professionals from a variety of creative and unconventional careers over dinner.

This club is a very small but dynamic group of young women. They have had an active presence on Facebook so please "like" them and see what they post. They have had some serious challenges with membership and reporting to us which will continue to be addressed next year. Joan Hutcheson from Hamilton 2, Jelaine Foster and I have attended their weekly executive meetings when possible.
